COMMITTEE ON ETHICS

July 2014

The Committee continued to fulfill its responsibilities to advise and educate Members and staff on the laws, rules, and standards of conduct. (An enumeration of those laws and rules as they stood at the end of the 112th Congress is found in H. Rep. 112-739, *Summary of Activities, One Hundred Twelfth Congress, A Report of the Committee on Ethics*, 112th Cong., 2d Sess. (December 31, 2012).) As a general matter, the Committee's activities in receiving and responding to requests for advice from House Members and staff are conducted on a confidential basis. The Committee received 49 requests for advisory opinions in July of 2014. Advisory materials the Committee has publicly released are available on the Committee's Web site, at <http://ethics.house.gov/>.

In accordance with the Rules of the House of Representatives of the 113th Congress, the Committee continued to review and approve requests to accept privately-sponsored, officially-connected travel. The Committee received 199 such requests in July of 2014.

In addition, the Committee is required under the House rules to offer annual ethics training to each Member, Delegate, Resident Commissioner, officer and employee of the House. Such training is mandatory for all House officers and employees, and new officers or employees must receive training not later than 60 days after beginning service to the House. The Committee continued to provide such training in July of 2014. The Committee provided live training sessions attended by 181 individuals in July of 2014. The Committee also continued to provide training online, through a number of training videos. The Committee released one general advisory report in July of 2014. The Committee released a general advisory report on July 11, titled *Update to guidance on the disclosure of privately-sponsored travel*. The Committee released three public statements in July of 2014. Chairman K. Michael Conaway and Ranking Member Linda T. Sánchez released one statement on July 3rd, 2014, regarding the disclosure of privately sponsored travel, and two statements on July 25, 2014, regarding the handling of matters referred to the Committee by the Office of Congressional Ethics.
