Vehicle Gates	The Washington & C Street, SW entrance, the Independence & New Jersey Avenue, SE entrance, the 2nd & Virginia Ave, SW entrance, and the 1st & C Street, SE entrance will be open. All other access points will be closed.
Parking	Only the Cannon garage, Rayburn garage, the Ford garage and lots 1, 4, 5, 7, and 9 will be open. Members/staff with permits for parking garages that are closed may park in Cannon, Rayburn, or any open outdoor lot.
Doors	Only two doors to each House Office Building will be open. Members and staff will be directed to the front of all lines.
