COMMITTEE ON ETHICS

August 2012

The Committee continued to fulfill its responsibilities to advise and educate Members and staff on the laws, rules, and standards of conduct. (An enumeration of those laws and rules is found in H. Rep. 111-707, *Summary of Activities, One Hundred Eleventh Congress, A Report of the Committee on Standards of Official Conduct*, 111th Cong., 2d Sess. (Jan. 3, 2011).) As a general matter, the Committee's activities in receiving and responding to requests for advice from House Members and staff are conducted on a confidential basis. The Committee received 32 requests for advisory opinions in August of 2012. Advisory materials the Committee has publicly released are available on the Committee's Web site, at <http://ethics.house.gov/>.

In accordance with the Rules of the House of Representatives of the 112th Congress, the Committee continued to review and approve requests to accept privately-sponsored, officially-connected travel. The Committee received 41 such requests in August of 2012.

In addition, the Committee is required under the House rules to offer annual ethics training to each Member, Delegate, Resident Commissioner, officer and employee of the House. Such training is mandatory for all House officers and employees, and new officers or employees must receive training not later than 60 days after beginning service to the House. The Committee continued to provide such training in August of 2012. The Committee provided live training sessions attended by 151 individuals in August of 2012. The Committee also continued to provide training online, through a number of training videos. Additional information about the calendar of upcoming in-person training sessions and online training opportunities is available on the Committee's Web site, at <http://ethics.house.gov/>.

The Committee released a general advisory on August 17, 2012, Periodic Reporting of Personal Financial Transactions Pursuant to the STOCK Act, as amended. The general advisory is available on the Committee's Web site, at <http://ethics.house.gov/>.

The Committee released four public statements regarding investigative matters in August of 2012. The Chairman and Ranking Member submitted a report to the House of Representatives in the Matter of Allegations Relating to Representative Laura Richardson, and recommended the House adopt the report and with it a reprimand of Representative Richardson. The Acting Chairman Bob Goodlatte and Acting Ranking Member John Yarmuth in the Matter of Representative Maxine Waters released a public statement, on August 2, 2012, that the Committee voted unanimously to extend the contract of William R. Martin as outside counsel. The Chairman and Ranking Member released a public statement on August 7, 2012, regarding S. 3510 and Periodic Transaction Reports (PTRs), explaining changes to the STOCK Act, S. 2038. The Chairman and Ranking Member released a public statement on August 31, 2012, regarding Representative Robert Andrews that they jointly decided to extend the matter and publish the


