LETTERS

Chairman Frank Pallone, Jr. with Subcommittee Chairs and other House and Senate Leaders

April 1, 2020 – Chairman Pallone, Committee on the Judiciary Chairman Jerrold Nadler, Committee on Oversight and Reform Chairwoman Carolyn B. Maloney, Committee on Science, Space, and Technology Chairwoman Eddie Bernice Johnson, Committee on Transportation and Infrastructure Chairman Peter DeFazio, Committee on Natural Resources Chairman Raúl M. Grijalva, Committee on Homeland Security Chairman Bennie G. Thompson, Committee on Financial Services Chairwoman Maxine Waters, Committee on Foreign Affairs Chairman Eliot L. Engel, Committee on Education and Labor Chairman Robert C. “Bobby” Scott, Committee on Ways and Means Chairman Richard E. Neal, Committee on Small Business Chairwoman Nydia M. Velázquez, Committee on Veterans’ Affairs Chairman Mark Takano, and Committee on Armed Services Chairman Adam Smith sent a joint letter to the Office of Management and Budget (OMB) Acting Director Russell T. Vought expressing concerns that the ongoing coronavirus pandemic is affecting the right of the American people to meet with federal agencies and comment on proposed actions. The letter urges Acting Director Vought to direct federal agencies to immediately reschedule all public hearings and meetings and extend public comment periods by at least 45 days.

April 2, 2020 – Chairman Pallone and Subcommittee on Communications and Technology Chairman Mike Doyle sent a letter to Federal Communications Commission (FCC) Chairman Ajit V. Pai expressing concerns regarding recent actions taken by the Donald J. Trump for President campaign against certain broadcasters. On March 25, the Trump campaign sent letters to certain broadcasters regarding the airing of an advertisement critical of the President’s response to the coronavirus pandemic, writing that it could put the station’s license in jeopardy. According to the Constitution and the Communications Act, the FCC must refrain from censoring or interfering with broadcasters’ discretion to air legally protected content. The letter urges the FCC to reassure broadcasters that the FCC will not revoke licenses for airing legally protected speech.

April 3, 2020 – Chairman Pallone, Ranking Member Greg Walden, Subcommittee on Consumer Protection and Commerce Chair Jan Schakowsky, and Subcommittee on Consumer Protection and Commerce Ranking Member Cathy McMorris Rodgers sent a letter to Federal Trade Commission (FTC) Chairman Joseph J. Simons regarding rampant reports of scams and frauds related to the COVID-19 pandemic. The letter applauds the FTC for its ongoing efforts to notify consumers of scams, such as free home testing kits, bogus cures, and price gouging during this unprecedented time. The letter urges the FTC to use all its tools, including law enforcements tools and coordination with State attorneys general, to act against scammers trying to steal from vulnerable Americans. The letter requests that the FTC provide a summary of enforcement activities on a biweekly basis.

April 14, 2020 – Chairman Pallone and Subcommittee on Oversight and Investigations Chair Diana DeGette sent a letter to U.S. Department of Health and Human Services (HHS) Secretary Alex M. Azar II expressing concerns about the Trump Administration’s commitment to the independence of the HHS Office of Inspector General (OIG). The letter describes the President’s pattern of conduct towards Inspectors General as corrosive and gravely concerning. The letter calls on HHS to ensure that the long-recognized principle of the OIG

independence remains respected and expects that HHS will cooperate fully and openly with any OIG evaluations, audits, and investigations.

April 15, 2020 – Chairman Pallone sent a letter to the Centers for Medicare and Medicaid Services (CMS) Administrator Seema Verma regarding COVID-19 outcomes data. The letter requests that CMS immediately release critical demographic data concerning the outcomes of COVID-19 based on race, ethnicity, and gender. The letter also urges that CMS quickly analyze and make public this essential data to ensure the federal government, as well as states and localities, can efficiently respond to and appropriately address clear disparities in COVID-19 care.

April 16, 2020 – Chairman Pallone, House Committee on Oversight and Reform Chair Carolyn B. Maloney, and Senate Committee on Health, Education, Labor and Pensions Ranking Member Patty Murray sent a joint letter to U.S. Department of Health and Human Services (HHS) Secretary Alex M. Azar II expressing concerns that ideologically motivated restrictions on federally funded research utilizing fetal tissue may be blocking efforts to develop vaccines and treatments for the 2019 novel coronavirus. The letter urges HHS to reverse restrictions on any studies utilizing fetal tissue conducted by government scientists and those relying on or seeking federal funding for COVID-19-related scientific research. The letters also requests a briefing on the appeals process for researchers seeking National Institutes of Health (NIH) funding to support research that involves use of fetal tissue and the status of the Administration’s decision about whether to allow the use of fetal tissue in research toward the development of vaccines and therapeutics for COVID-19.

April 20, 2020 – Chairman Pallone sent a letter to Dr. Deborah L. Birx, White House Coronavirus Task Force Coordinator, expressing concern about the lack of widespread testing in the U.S., and what the ramifications will be if social distancing efforts are prematurely eased without robust testing in place to detect the spread of COVID-19. The letter requests information regarding the Administration’s plan for expanding testing and reopening the economy.

April 20, 2020 – Chairman Pallone, Subcommittee on Health Chairwoman Anna Eshoo, and Subcommittee on Oversight and Investigations Chair Diana DeGette sent a letter to U.S. Department of Health and Human Services (HHS) Secretary Alex M. Azar II and Federal Emergency Management Agency (FEMA) Administrator Peter T. Gaynor expressing concerns about the lack of transparency from the Administration as to how it is responding to states’ requests for supplies and distributing them to the areas of greatest need. The letter requests information about COVID-19 supply quantities and distribution, in addition to more details about the Supply Chain Stabilization Task Force.

April 21, 2020 – Chairman Pallone, Committee on Transportation and Infrastructure Chair Peter A. DeFazio, and Committee on Appropriations Subcommittee on Interior, Environment, and Related Agencies Chair Betty McCollum sent a letter to U.S. Environmental Protection Agency (EPA) Administrator Andrew Wheeler regarding the EPA Office of Enforcement and Compliance Assurance’s recent guidance regarding the relaxations of enforcement of environmental legal obligations during the COVID-19 pandemic. The letter requests a written explanation as to how EPA plans to modify or adjust its policy directive for requested modifications, and information regarding public health considerations and stakeholder engagement, in addition to a briefing on the issue.

April 22, 2020 – Chairman Pallone, Subcommittee on Health Chairwoman Anna Eshoo, and Subcommittee on Oversight and Investigations Chair Diana DeGette sent a letter to Office of Management and Budget (OMB)

Acting Director Russell T. Vought expressing serious concerns about President Trump’s decision to suspend funding for the World Health Organization (WHO) during the COVID-19 pandemic. The letter requests information to better understand the process by which the Administration decided to suspend U.S. funding for WHO and to assess the potential public health impact of the President’s decision.

April 23, 2020 – Chairman Pallone sent a letter to Principal Deputy Inspector General of the Office of Inspector General of the U.S. Department of Health and Human Services Christi A. Grimm concerning reports that one of the U.S. government’s top public health officials was recently moved out of his central role responding to the COVID-19 pandemic allegedly for political reasons. The letter urges Principal Deputy Inspector General Grimm to investigate the circumstances surround the reassignment of Dr. Rick Bright.

April 30, 2020 – Chairman Pallone, Subcommittee on Health Anna Eshoo, and Subcommittee on Oversight and Investigations Chair Diana DeGette sent a letter to U.S. Department of Health and Human Services (HHS) Secretary Alex M. Azar II expressing serious concerns regarding the Trump Administration’s lack of a coordinated and comprehensive plan to increase the Nation’s contact tracing capacity in response to the COVID-19 pandemic. The letter requests information regarding the status and progress of coordination across the Federal Government, including among HHS agencies and others, to expand the capability and capacity of the public health workforces, contact tracing, and other COVID-19-related efforts.

COMMITTEE TELECONFERENCE FORUMS

Committee on Energy and Commerce

April 22, 2020 – Chairman Pallone, along with Ranking Member Greg Walden, led a bipartisan teleconference forum for Committee members with Stephen Hahn, M.D., Administrator of the U.S. Food and Drug Administration (FDA). The forum focused upon the FDA’s response to the coronavirus pandemic, with review of the role of FDA ensuring the safety and accuracy of diagnostic and serological tests. Dr. Hahn also updated the Committee on efforts to supply much-needed medical devices, including testing supplies and the development of potential COVID-19 treatments and vaccines.

April 30, 2020 – Chairman Pallone, along with Ranking Member Greg Walden, led a bipartisan teleconference forum for Committee members with Francis Collins, M.D., Ph.D., Director of the National Institutes of Health (NIH). Committee members were updated by Dr. Collins on the agency’s work to help develop COVID-19 therapeutics and vaccines and discussed readiness efforts to prepare for a future vaccine. Committee members underscored the importance of validating serological tests and received an update on NIH’s research efforts to better understand the coronavirus.

Information from the Committee for the Congress and the Public

During the month of April, the Committee on Energy and Commerce staff, at the direction of the Chairman and its members, worked on developing and providing the best tools to enable its members to safely convene and work together on the important issues under the Committee's jurisdiction. Several teleconference meetings were held by both the majority and minority caucuses of the Committee that contributed to determining the priority issues of the pandemic. Among the Committee's earliest work products as the pandemic arrived in the U.S. was creation of several fact sheets providing vital information on COVID-19, along with publishing website links to important pandemic resources.
