Ninety-Day Plan

As of the date of this interim report, while subject to change, the Select Committee expects the agenda for the next ninety days to include but not be limited to the following hearings and business meetings:

October 21 committee hearing titled, "Modernizing the Congressional Support Agencies to Meet the Needs of an Evolving Congress." Congressional support agencies, which are tasked with providing members and staff with up-to-date analysis, are challenged to keep up. This hearing will consider what modern support agencies would look like and what it would take to transform the Congressional Research Service (CRS), Congressional Budget Office (CBO), and Government Accountability Office (GAO) into agencies equipped to manage the challenges of today and the future. The hearing will also consider how information can be packaged and provided in a more modern, easy to understand way for both public and private consumption. Note that this hearing was originally scheduled for September 28 and was postponed due to a conflict with votes.

October 27 committee hearing titled, "Improving the Lawmaking Process: Evidence-Based Legislating." This hearing will consider the need for impartial statistical, scientific, and technological analysis in Congress. Broadly, it will look at how the Evidence Act of 2018 (Public Law No. 115-435) changed the landscape when it comes to evidence-based policymaking and what things can be done in Congress to build on the changes that legislation enacted across the executive branch. It will look at potential options for providing members, committees, and staff with timely, impartial analyses of complicated scientific and technological issues. Topics will likely include the development of a training program for congressional staff on the understanding and interpretation of evidence; establishing best practices for drafting legislation in a way that allows for better program implementation and that will aid future data gathering for program evaluation by Congress; and explore recommendations for de-siloing data that already exists.

November 4 committee hearing titled, "Improving the Lawmaking Process: Bolstering Congressional Oversight Capacity." This hearing would focus on topics like using the budget process to re-assert congressional power, reforms to lower barriers to oversight, and regaining oversight powers that Congress previously abdicated. Some of these topics were introduced in the Committee's January 2020 Article One hearing.

November 16 member meeting (tentative), discussion on second package of recommendations.

December 2 member meeting (tentative), discussion on second package of recommendations.

December 8 business meeting expected vote on second package of Select Committee recommendations.

Transcripts of Committee Proceedings – Q3

On July 20, 2021, the Committee held a hearing titled, "Rethinking the Committee and Sharing Best Practices." This hearing featured two panels, one consisting of two senior members of Congress and another consisting of two former senior House committee aides and a professor of political science whose research examines congressional agenda setting and committee power. The hearing focused on the central role committees play in Congress's governing responsibilities and how to strengthen their role within the institution. On July 29, 2021, the Committee held a business meeting to vote on, and approve, the first package of Select Committee recommendations for the 117th Congress. The full transcript of the business meeting can be found here: <u>Business Meeting to Consider Slate of Recommendations</u>.

On September 23, 2021, the committee held a hearing, "Pathways to Success: How Practicing Civility, Collaboration, and Leadership Can Empower Members." While the committee's July 20 hearing on enhancing committee productivity touched on the topic of empowering members, this hearing focused on how members who pursue a civil, collaborative, and leadership-oriented approach to their work in Congress are better able to achieve their policy and political goals. Witnesses discussed how members who take a collaborative approach are better able to meet their legislative and electoral goals; how members who are civil in their interactions with colleagues and employees are more likely to earn respect and be viewed as leaders; and how exercising strong leadership can help members achieve their goals. In addition to these hearings, the Select Committee hosted several "brown bags" for Congressional staff. These four informal discussions included both internal and external guests, including the Partnership for Public Service, House Recording Studio, Congressional Staff Academy, and others. The committee also held virtual listening sessions with Congressional staff to receive their input on what policies could improve the work that they do. The committee hosted eight total listening sessions during Q3 with both district staff and Washington, D.C.based staff.
