The Subcommittee on Health held a hearing on **Thursday, May 14, 2020**, entitled, “Protecting Scientific Integrity in the COVID-19 Response.” The witness was Rick Bright, Ph.D., former Director of the Biomedical Advanced Research and Development Authority of HHS (BARDA), and Mr. Michael L. Bowen, Executive Vice President of Prestige Ameritech.

LETTERS

Chairman Frank Pallone, Jr., Subcommittee Chairs and other House and Senate Leaders

May 1, 2020 – Chairman Pallone and House Committee on Ways and Means Chairman Richard E. Neal sent a joint letter to Alex M. Azar II, Secretary of the Department of Health and Human Services (HHS) and Seema Verma, Administrator of the Centers for Medicare & Medicaid Services, expressing concerns about the Provider Relief Fund and the Accelerated and Advance Payment Program. The letter expresses concern about the lack of transparency with Congress and the American people regarding how funds are being spent and loans are being made. The chairmen request responses to questions about both programs.

May 1, 2020 – Chairman Pallone, along with other House health leaders Committee on Ways and Means Chairman Richard E. Neal, Committee on Education and Labor Committee Chairman Bobby Scott, and Committee on Oversight and Reform Chairwoman Carolyn B. Maloney, sent a joint letter to Alex M. Azar II, Secretary of the Department of Health and Human Services (HHS) about a rule to overturn core protections for marginalized communities including LGBTQ+ people, women, individuals with limited English proficiency, and individuals with disabilities, and eliminate many health care programs and activities from coverage of the Affordable Care Act’s nondiscrimination requirements. The House leaders urging Secretary Azar not to finalize this troubling rule and to instead focus on responding to the COVID-19 pandemic.

May 5, 2020 – Chairman Pallone and Senate Finance Committee Ranking Member Ron Wyden (D-OR) wrote a letter to Alex M. Azar II, Secretary of the Department of Health and Human Services, expressing concerns that roughly \$70 billion has been distributed to health care providers under the CARES Act in a way that discriminates against Medicaid-dependent health care providers. Chairman Pallone and Ranking Member Wyden included a series of questions and asked the HHS Secretary to describe how much funding will go to Medicaid-dependent health care providers.

May 7, 2020 – Chairman Pallone and House Committee on Ways and Means Chairman Richard E. Neal sent a joint letter to Alex M. Azar II, Secretary of the Department of Health and Human Services (HHS) and Seema Verma, Administrator of the Centers for Medicare & Medicaid Services (CMA), raising a series of concerns over the methodology used to distribute and the lack of transparency into how COVID-19 relief funds and loans for health care providers are being spent. The House leaders noted their grave concerns due to lack of transparency and methods used to run the Provider Relief Fund and the Accelerated and Advance Payment Programs enacted to distribute \$175 billion approved by Congress. The letter concluded with request for more expansive data and explanations on these programs being carried out by HHS and CMA.

May 8, 2020 – Chairman Pallone joined the following House Committee and Subcommittee chairs – Hon. Bennie G. Thompson, Homeland Security; Hon. Jerrold Nadler, the Judiciary; Hon. Nita Lowey, Appropriations; Hon. Lucille Roybal-Allard, Appropriations Homeland Security Subcommittee; Hon. Rosa DeLauro, Appropriations Subcommittee on Labor, Health and Human Services and Education; Hon. Kathleen Rice, Homeland Security Committee Border Security, Facilitation, and Operations Subcommittee; Hon. Zoe Lofgren, Judiciary Committee Subcommittee on Immigration and Citizenship;

and Hon. Diana DeGette, Committee on Energy and Commerce Chair of Subcommittee on Oversight and Investigations – in sending a letter to the Department of Homeland Security (DHS) and the Department of Health and Human Services (HHS) regarding recent reports alleging that the Trump Administration is considering implementing policies that could unnecessarily delay migrant children in HHS care from being reunified with their sponsors. The House leaders again urged the Administration to rescind a Memorandum of Agreement requiring information about sponsors for migrant children be shared by HHS with DHS.

May 12, 2020 – Chairman Pallone and Subcommittee on Oversight and Investigations Chair DeGette sent a letter to Centers for Disease Control and Prevention (CDC) Director Robert R. Redfield regarding the CDC’s effort to protect food production workers from the dangers of the coronavirus disease. They expressed concerns that the CDC guidance provided to date to food production facilities has been insufficient to address the increased risks that these workers face during this pandemic. The letter requests a briefing and responses to questions regarding the efforts CDC is taking to assist in ongoing endeavors to keep workers safe.

May 14, 2020 – Chairman Pallone and Ranking Member Walden sent a letter to Committee on Appropriations Chairwoman Lowey and Ranking Member Granger regarding the funding of H.R. 4998, the Secure and Trusted Communications Networks Act. The letter expresses concerns that, although the Act was signed into law, it remains unfunded. They urge the Committee to fund the Secure and Trusted Program, as it is vital to help ensure that networks throughout the country are free from malicious foreign interference.

May 18, 2020 – Chairman Pallone and Subcommittee on Oversight and Investigations Chair DeGette sent a letter to Chief Executive Officer of Blue Flame Medical LLC, Mike Gula, regarding concerns about numerous reports regarding Blue Flame Medical LLC’s failure to deliver critical medical supplies under its contracts with state and local governments and nonprofit health care providers. The letter expresses concerns about the PPE shortages being reported by providers across the Nation, and Blue Flame’s failure to fulfill multiple orders placed by states and local entities working on the pandemic response. The letter requests responses to questions to better understand Blue Flame’s involvement in COVID-19 response efforts.

May 21, 2020 – Chairman Pallone, Ranking Member Walden, Subcommittee on Oversight and Investigations Chair DeGette, and Subcommittee on Oversight and Investigations Ranking Member Guthrie sent a letter to the Coronavirus Task Force Coordinator Deborah L. Birx, M.D., regarding the Trump Administration’s planning efforts related to a future vaccine for COVID-19. The letter expresses concern that the Administration has not released a comprehensive COVID-19 vaccine plan. The letter requests a briefing and responses to questions included in the letter regarding “Operation Warp Speed,” a COVID-19 countermeasure development, manufacturing, and distribution framework released by the Administration.

May 22, 2020 – Chairman Pallone and Senate Health, Education, Labor and Pensions Ranking Member Patty Murray (D-WA) wrote a letter to Alex M. Azar II, Secretary of the Department of Health and Human Services, demanding the Trump Administration update and resubmit the report it provided regarding COVID-19 demographic data. They wrote that the Administration’s submission fails to meet the requirements of the Paycheck Protection Program and Health Care Enhancement Act and that an updated version with comprehensive demographic data must be provided.

May 27, 2020 – Chairman Pallone and Subcommittee on Oversight and Investigations Chair DeGette sent a letter to Food and Drug Administration Commissioner Stephen Hahn regarding the FDA’s efforts

to ensure the supply of safe food in the United States during the COVID-19 pandemic. The letter expresses concerns that the potential spread of harmful foodborne pathogens does not stop while the Nation responds to COVID-19. They request responses to questions regarding the ongoing threats COVID-19 poses to the global food supply chain and the availability of safe food in the United States.

COMMITTEE TELECONFERENCE FORUMS
Committee on Energy and Commerce

May 1, 2020 – Members of the Committee on Energy and Commerce Subcommittee on Health and Subcommittee on Oversight and Investigations held a bipartisan teleconference forum with Anne Schuchat, M.D., Principal Deputy Director of the Centers for Disease Control and Prevention (CDC). The forum’s focus was discussion on racial disparities I health outcomes for COVID-19 patients.

May 4, 2020 – Members of the Committee on Energy and Commerce held a bipartisan teleconference forum with Admiral Brett P. Giroir, M.D., Assistant Secretary of Health for the Department of Health and Human Services, on the Administration’s COVID-19 testing efforts. of the Centers for Disease Control and Prevention (CDC). The forum’s focus was discussion on racial disparities I health outcomes for COVID-19 patients.

May 8, 2020 – Members of the Committee on Energy and Commerce held a bipartisan teleconference forum with three health experts to discuss COVID-19 testing, contact tracing, and surveillance. The teleconference will be conducted with Andy Slavitt, former Acting Administrator of the Centers for Medicare & Medicaid Services (CMS) (2015-2017); Mark McClellan, M.D., Ph.D., former Administrator of the CMC (2004-2006) and former Commissioner of the Food and Drug Administration (FDA) (2002-2004); and Avik Roy, Co-founder and President of the Foundation for Research on Equal Opportunity.

May 11, 2020 – Members of the Subcommittee on Consumer Protection and Commerce of the Committee on Energy and Commerce held a bipartisan teleconference forum with Joseph J. Simons, Chairman of the Federal Trade Commission (FTC), to discuss critical consumer protection issues relating to the COVID-19 pandemic.

May 19, 2020 – Members of the Subcommittee on Communications and Technology of the Committee on Energy and Commerce held a bipartisan teleconference forum with Federal Communications Commission (FCC) Chairman Ajit Pai to discuss critical consumer protection, broadband, and spectrum issues related to the COVID-19 pandemic. This forum was open to the press.

May 20, 2020 – Members of the Committee on Energy and Commerce held a bipartisan teleconference forum with Greg Burel, former Director of the Strategic National Stockpile (SNS) (March 2007 – January 2020). The Members discussed with Mr. Burel the critical role the Strategic National Stockpile plays in a public health emergency. The forum was important as the Committee continues to work on the national coronavirus response and ensuring improved readiness of the Stockpile for future needs.

Information from the Committee for the Congress and the Public

During the month of May, the Committee on Energy and Commerce staff, at the direction of the Chairman and its members, worked on developing and providing the best tools to enable its members to safely convene and work together on the important issues under the Committee's jurisdiction. Several teleconference meetings were held by both the majority and minority caucuses of the Committee that contributed to determining the priority issues of the pandemic. Among the Committee's earliest work products as the pandemic arrived in the U.S. was creation of several fact sheets providing vital information on COVID-19, along with publishing website links to important pandemic resources.
