Alex M. Azar II, Secretary of the Department of Health and Human Services, regarding the Administration's termination of the National Institutes of Health grant to the EcoHealth Alliance.

September 10, 2020 – Chairman Pallone and Ranking Member Greg Walden, Reps. Carolyn Maloney, Chairwoman, and James Comer, Ranking Member, Committee on Oversight and Reform, along with Senators Charles Grassley, Chairman, and Ron Wyden, Ranking Member Senate Finance Committee, Senators Lamar Alexander, Chairman, and Patty Murphy, Ranking Member, Senate Health, Education, Labor and Pension Committee, sent a joint letter to Gene Dodaro, Comptroller General of the United States, Government Accountability Office, requesting a legal opinion about contracts to private communications consultants made by Hon. Seema Verna, Administrator of the Centers for Medicare and Medicaid.

September 11, 2020 – Chairman Pallone sent a letter to Hon. Alex M. Azar II, Secretary of the Department of Health and Human Services (HHS), regarding Performance Work Statement issued by HHS for a communications contract regarding the COVID-19 pandemic.

Azar II, Secretary of Health and Human Services, regarding political interference in the Centers for Disease Control and Prevention morbidity and mortality weekly reports.

September 15, 2020 – Chairman Pallone, along with Subcommittee on Health Chairwoman Eshoo, and Subcommittee on Oversight and Investigations Chair DeGette, sent oversight letters to the following nine pharmaceutical companies seeking information on COVID-19 vaccine research and development efforts: Pascal Soriot, Executive Director and CEO of AstraZeneca; Ugur Sahin, M.D., CEO of BioNTech; Emma Walmsley, CEO of GlaxoSmithKline; Kenneth C. Frazier, Chairman and CEO of Merck and Co.; Stephane Bancel, CEO of Moderna; Alberta Bourla, D.V.M., Ph.D., Chairman and CEO of Pfizer; Alex Gorsky, Chairman and CEO of Johnson and Johnson; Stanley C. Erckl, President and CEO of Novavax; and Paul Hudson, CEO of Sanofi. The letters asked six questions about the stage of vaccine development, vaccine safety, and to make clinical trial data publicly available. The answers are due by October 2, 2020.
