### ACTIVITIES OF THE COMMITTEE ON SMALL BUSINESS 112<sup>TH</sup> CONGRESS, 2<sup>nd</sup> SESSION

#### MAY 2012 COMMITTEE HEARINGS

May 9, 2012: "Running on Empty: The Effects of High Gasoline Prices on Small Businesses" Persistently high gasoline prices are draining family budgets and putting increased stress on small businesses. According to a recent survey by the Small Business and Entrepreneurship Council, 72 percent of small businesses report they are affected by high energy prices. Of these businesses, 41 percent report that they have altered hiring plans and another 22% report reducing employee hours. Small businesses are the historic source of new job creation in the economy, but are currently facing many challenges, including the burden of high fuel prices, that inhibit their ability to invest, grow and hire new workers. The hearing studied the relationship between high gasoline prices and small businesses.

May 16, 2012: "U.S. Trade Strategy: What's Next for Small Business Exporters?" The Committee met to receive testimony concerning the trade policy initiatives of the Administration and their effect on small business exporters. Specifically, the Committee heard from the Office of the United States Trade Representative (USTR) on the status of current trade negotiations and the overall strategy to open new markets for United States goods and services. In addition, the Committee received recommendations directly from small businesses on how to increase their exports and create new local jobs.

### Subcommittee on Economic Growth, Tax and Capital Access

May 31, 2012: "Planning for the Death Tax: Can Small Businesses Survive?" The recession has been hard on small businesses, and many family-owned small firms may face yet another hurdle: business succession and the impact of the death tax, also known as the estate tax. If Congress fails to act, the current federal estate tax law will expire on December 31, 2012, and revert to the pre-2001 levels. At this hearing, Members heard testimony on the impact of the estate tax on small businesses and the economy.
