LETTERS

Chairman Frank Pallone, Jr. with Subcommittee Chairs and other House and Senate Leaders

August 1, 2019 – Chairman Pallone, Chairman Scott, Chairman Cummings, and Ranking Member Murray sent a letter to U.S. Department of Health and Human Services (HHS) Secretary Alex Azar requesting documents and information regarding the refusal of care rule, titled Protecting Statutory Conscience Rights in Health Care; Delegations of Authority, which was finalized by HHS’s Office for Civil Rights (OCR). The final rule adopts an overly expansive view of existing refusal of care laws and dramatically expands the ways in which existing refusal of care laws can be used to sanction discrimination. The letter asked for HHS documents regarding the reason for changing the rule as well as the response to seven questions.

August 6, 2019 – Chairman Pallone and Ranking Member Walden sent a letter to United States Trade Representative Ambassador Robert E. Lighthizer expressing concerns regarding the inclusion of Article 19.17 in the United-States-Mexico-Canada Agreement (USMCA). Article 19.17 mirrors that of Section 230 of the Communications Decency Act and the role such a liability shield may have has become the subject of much debate. Given the Committee closely oversees Section 230 and all portions of the Telecommunications Act of 1996, the Committee hopes to be consulted in advance of negotiating on these issues.

August 7, 2019 – Chairman Pallone, Ranking Member Walden; Oversight and Investigations Subcommittee Chair Diana DeGette; and Subcommittee Ranking Member Brett Guthrie sent a letter to the Government Accountability Office (GAO) asking them to examine the Department of Homeland Security’s deployment of a new biodetection technology system called BioDetection 21 (BD21) to replace Bio Watch and the status of DHS’s implementation of BD21. Given the Committee’s interest in the adequacy of the science of biodetection technology, the letters requests the answer to three questions regarding BioWatch and BD21.

August 20, 2019 – Chairman Pallone; Subcommittee on Environment and Climate Change Subcommittee Chairman Paul Tonko; and Subcommittee on Oversight and Investigations Subcommittee Chair Diana DeGette sent a letter to the U.S. Environmental Protection Agency (EPA) Administrator regarding changes to procedures for resolving challenges to EPA permits through the EPA Environmental Appeals board (EAB). These proposed changes could disproportionately harm poor and minority communities and limit the ability of communities to

challenge the Agency's permitting decisions. The letter requests the answer to nine questions as well as a request that the EPA brief the Committee on the Agency's efforts to revise the role of the EAB in EPA's adjudication process.

August 21, 2019 - Chairman Pallone sent 4 separate letters to the Richard Hill, CEO of Fentum Ventures (Fontem); Ricardo Oberlander, CEO of Reynolds American Inc.'s; Kevin Burns, CEO of JUUL Labs, Inc.'s; and Eddie Pirard, President and CEO of Japan Tobacco International, USA, Inc. regarding the public health implications of electronic nicotine delivery systems (ENDS), including electronic cigarettes (e-cigarettes). The letter requests information to better understand the companies research pertaining to the public health impact of e-cigarette use in adolescents under the age of 21. The concern is that ENDS products are continuing to be marketed and used while consumers lack adequate information to evaluate the health implications of using these products. The letter requests the answer to thirteen questions regarding research they have done or financed related to ENDS products as well as other information.

August 26, 2019 – Chairman Pallone sent a letter to Robert R. Redfield, Director of the Centers for Disease Control and Prevention; Jerome M. Adams, Surgeon General of the United States; and Robert Kadlec, Assistant Secretary for Preparedness and Response regarding reports that U.S. Customs and Border Protection (CBP) is not currently providing nor plans to provide influenza vaccines to migrant children, adults, and in CBP custody. This letter implores CBP to provide influenza vaccinations to all detained individuals; but especially to detained children, in order to best protect them from influenza and prevent unnecessary illness, hospitalizations, or additional deaths ahead of this upcoming flu season.
