- H.R. 8281 - *Safeguard American Voter Eligibility Act ("SAVE" Act)*
- H.R. 8399 - *Preventing Foreign Interference in American Elections Act*
- H.R. 7640 - *No Foreign Persons Administering Our Elections Act*
- H.R. 4544 - *No Federal Funds for Ballot Harvesting Act*
- H.R. 4317 - *To amend the National Voter Registration Act of 1993 to require States to submit a report to the Election Assistance Commission that includes information with respect to the voter list maintenance activities of the State, and for other purposes.*
