November 10, 2020 – Chairman Pallone along with Subcommittee on Communications and Technology Chairman, Mike Doyle sent a letter to Hon. Ajit Pai, Chairman of the Federal Communications Commission (FCC) requesting the FCC stop work on all partisan controversial matters and follow the norms set by past transfers of power.

November 10, 2020 – Chairman Pallone and Subcommittee on Consumer Protection and Commerce Chairwoman, Jan Schakowsky sent letter to Hon. Joseph Simons, Chairman of the Federal Trade Commission (FTC) requesting the FTC to stop work on all partisan controversial matters and follow the norms set by past transfers of power.

November 23, 2020 – Chairman Pallone and Ranking Member Walden wrote to Hon. Ajit Pai, Chairman of the Federal Communications Commission (FCC) to urge the FCC to assist companies in replacing suspect network equipment, including companies eligible for reimbursement under Secure and Trusted Reimbursement Program.

During the month of November, the Committee on Energy and Commerce staff, at the direction of the Chairman and its members, worked on developing and providing the best tools to enable its members to safely convene and work together on the important issues under the Committee's jurisdiction.
