## **Committee Letters**

The Committee sent the following letters in January:

- January 11, 2021—Letter to the Honorable Russell Vought, Director, Office of Management and Budget (OMB), and Jeffrey Rosen, Acting Attorney General, U.S. Department of Justice (DOJ), expressing concern regarding a draft final rule titled *Amendment of the Title VI Regulations* and requesting that OMB provide the text of the draft final rule as well as any justification DOJ has articulated for bypassing the normal notice and comment period. This was a joint letter with House Committee on the Judiciary Chair Jerrold Nadler and House Committee on Oversight and Government Reform Chair Carolyn Maloney.
- January 11, 2021—Letter to the Honorable Gene Dodaro, Comptroller General of the United States, U.S. Government Accountability Office, requesting to join as an addressee on any current or future studies of labor and worker protection issues that GAO conducts in response to Public Law 116-136, the Coronavirus Aid, Relief, and Economic Security Act; Title IX. Sec. 19010.
- January 19, 2021—Letter to the Honorable Mitchell Zais, Acting Secretary, U.S. Department of Education raising concerns regarding reports a public-school district is transmitting student educational records to a local sheriff's office, so that the sheriff's office could develop a list of students "destined for a life of crime."
