H.R. 734	Committee on Education and the Workforce	Protection of Women and Girls in Sports Act of 2023
H.J. Res. 42	Committee on Oversight and Accountability	Disapproving the action of the District of Columbia Council in approving the Comprehensive Policing and Justice Reform Amendment Act of 2022.

The Committee granted, by record vote of 8-3, a rule providing for consideration of H.R. 734, the Protection of Women and Girls in Sports Act of 2023, and H.J. Res. 42, disapproving the action of the District of Columbia Council in approving the Comprehensive Policing and Justice Reform Amendment Act of 2022.

The rule provides for consideration of H.R. 734, the Protection of Women and Girls in Sports Act of 2023, under a structured rule. The rule waives all points of order against consideration of the bill. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Education and the Workforce or their respective designees. The rule provides that an amendment in the nature of a substitute consisting of the text of Rules Committee Print 118-3 shall be considered as adopted and the bill, as amended, shall be considered as read. The rule waives all points of order against the amendment in the nature of a substitute to H.R. 734 made in order as original text. The rule further makes in order only those amendments printed in the Rules Committee report. Each such amendment may be offered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment, and shall not be subject to a demand for division of the question in the House or in the Committee of the Whole. All points of order against the amendments are waived. The rule provides one motion to recommit.

The rule further provides for consideration of H.J. Res. 42, disapproving the action of the District of Columbia Council in approving the Comprehensive Policing and Justice Reform Amendment Act of 2022, under a closed rule. The rule waives all points of order against consideration of the joint resolution. The rule provides that the joint resolution shall be considered as read. The rule waives all points of order against provisions in the joint resolution. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Oversight and Accountability or their respective designees. Finally, the rule provides that pursuant to section 604(h) of the Home Rule Act, a motion to recommit is not in order to the joint resolution if under consideration while the act of the D.C. Council is within the congressional review period prescribed in section 602 of such Act.
