July 2023

The Committee on Ethics (Committee) continued to fulfill its responsibilities to advise and educate Members and staff on the laws, rules, and standards of conduct. As a general matter, the Committee's activities in receiving and responding to requests for advice from House Members and staff are conducted on a confidential basis. In July 2023, the Committee responded to over 1,700 phone calls and email messages seeking advice, and participated in many informal meetings with Members, House staff, and outside individuals or groups regarding specific ethics matters. The Committee also received 22 requests for formal advisory opinions.

In accordance with the Rules of the House of Representatives for the 118th Congress, the Committee continued to review and approve requests to accept privately-sponsored, officially-connected travel. The Committee received and reviewed 351 new travel requests in July 2023 for travel beginning in July or later. One hundred and twenty-four House employees traveled on a Committee-approved, privately-sponsored, officially-connected trip within the month of July.

The Committee is required under House rules to offer mandatory annual ethics training to each Member, Delegate, Resident Commissioner, officer, and employee of the House. The Committee is working to modernize its guidance in both substance and method of delivery. The Committee continued to provide training in July through live and on-demand offerings. Eighty-one individuals attended the live in-person Ethics training hosted by the Committee on July 21. Fifteen individuals also attended live virtual training provided by the Committee at the request of one office. The calendar of live in-person training opportunities is available [here](#).
