

The Subcommittee on Energy and Mineral Resources conducted the following hearings and/or meetings during the month of September 2011:

**Friday, September 9, 2011**—The Subcommittee on Energy and Mineral Resources held an Oversight Hearing on the “Impacts to Onshore Jobs, Revenue, and Energy: Review and Status of Sec. 390 Categorical Exclusions of the Energy Policy Act of 2005.”

**Tuesday, September 13, 2011**—The Subcommittee on Energy and Mineral Resources held a Legislative Hearing on H.R. 2360, to amend the Outer Continental Shelf Lands Act to extend the Constitution, laws, and jurisdiction of the United States to installations and devices attached to the seabed of the Outer Continental Shelf for the production and support of production of energy from sources other than oil and gas, and for other purposes.

**Tuesday, September 13, 2011**—The Subcommittee on Energy and Mineral Resources held a Legislative Hearing on H.R. 2752, to amend the Mineral Leasing Act to authorize the Secretary of the Interior to conduct onshore oil and gas lease sales through Internet-based live lease sales, and for other purposes.

**Tuesday, September 13, 2011**—The Subcommittee on Energy and Mineral Resources held a Legislative Hearing on H.R. 2803, to direct the Secretary of the Interior, acting through the Bureau of Ocean Energy Management, Regulation and Enforcement, to conduct a technological capability assessment, survey, and economic feasibility study regarding recovery of minerals, other than oil and natural gas, from the shallow and deep seabed of the United States.

FOR THE MONTH OF SEPTEMBER 2011**

The Subcommittee on National Parks, Forests and Public Lands conducted the following hearings and/or meetings during the month of September 2011:

- Friday, September 9, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on (Draft Bill) H.R. \_\_, to modify the Forest Service Recreation Residence Program by implementing a simple, equitable, and predictable procedure for determining cabin user fees, and for other purposes.
- Friday, September 9, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 1444, to require that hunting activities be a land use in all management plans for Federal land under the jurisdiction of the Secretary of the Interior or the Secretary of Agriculture to the extent that such use is not clearly incompatible with the purposes for which the Federal land is managed, and for other purposes.
- Friday, September 9, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 2834, to recognize the heritage of recreational fishing, hunting, and shooting on Federal public lands and ensure continued opportunities for these activities.
- Tuesday, September 13, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 302, to provide for State approval of national monuments, and for other purposes.
- Tuesday, September 13, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 758, to amend the Act popularly known as the Antiquities Act of 1906 to require certain procedures for designating national monuments, and for other purposes.
- Tuesday, September 13, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 817, to amend the Antiquities Act of 1906 to place additional requirements on the establishment of national monuments under that Act, and for other purposes.

- Tuesday, September 13, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 845, to prohibit the further extension or establishment of national monuments in Montana, except by express authorization of Congress, and for other purposes.
- Tuesday, September 13, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 846, to prohibit the further extension or establishment of national monuments in Idaho, except by express authorization of Congress, and for other purposes.
- Tuesday, September 13, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 2147, to prohibit the further extension or establishment of national monuments in Utah except by express authorization of Congress.
- Thursday, September 15, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 1162, to provide the Quileute Indian Tribe Tsunami and Flood Protection, and for other purposes.
- Thursday, September 15, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 2087, to remove restrictions from a parcel of land situated in the Atlantic District, Accomack County, Virginia.
- Thursday, September 15, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 2336, to amend the Wild and Scenic Rivers Act to designate segments of the York River and associated tributaries for study for potential inclusion in the National Wild and Scenic Rivers System.
- Thursday, September 15, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 2351, to direct the Secretary of the Interior to continue stocking fish in certain lakes in the North Cascades National Park, Ross Lake National Recreation Area, and Lake Chelan National Recreation Area.
- Thursday, September 15, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 2352, to authorize the Secretary of the Interior to adjust the boundary of the Stephen Mather Wilderness and the North Cascades National Park in order to allow the rebuilding of a road outside of the floodplain while ensuring that there is no net loss of acreage to the Park or the Wilderness, and for other purposes.
- Thursday, September 15, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 2606, to authorize the Secretary of the Interior to allow the construction and operation of natural gas pipeline facilities in the Gateway National Recreation Area, and for other purposes.
- Thursday, September 15, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 2687, to authorize the Secretary of the Interior to lease certain lands within Fort Pulaski National Monument, and for other purposes.
- Monday, September 19, 2011**—The Subcommittee on National Parks, Forests and Public Lands held an Oversight Field Hearing in Sacramento, California, on



“Restoring Public Access to the Public’s Lands: Issues Impacting Multiple-use on Our National Forests.”

**Thursday, September 22, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on (Draft Bill), H.R. \_\_\_, to increase employment and educational opportunities in, and improve the economic stability of, counties containing Federal forest lands, while also reducing the cost of managing such lands, by providing such counties a dependable source of revenue from such lands.

**Thursday, September 22, 2011**—The Subcommittee on National Parks, Forests and Public Lands held a Legislative Hearing on H.R. 2852, to authorize Western States to make selections of public land within their borders in lieu of receiving 5 percent of the proceeds of the sale of public land lying within said States provided by their respective enabling Acts.
