The following amendment was offered: An amendment (Manager's amendment) by Mr. Veasey, # 1, was adopted by a voice vote.
- (2) H.R. 2041, the "Weatherization Enhancement and Local Energy Efficiency Investment and Accountability Act" (Schrader and Carter of GA), was favorably forwarded to the full Committee, without amendment, by a voice vote.
- (3) H.R. 2119, a bill to amend the Energy Policy Act of 2005 to reauthorize grants for improving the energy efficiency of public buildings, and for other purposes (*Kelly of IL*), was favorably forwarded to the full Committee, without amendment, by a voice vote.
- (4) H.R. 1315, the "Blue Collar to Green Collar Jobs Development Act of 2019" (*Rush of IL*), was favorably forwarded to the full Committee, without amendment, by a voice vote.
- (5) H.R. 2665, the "Smart Energy and Water Efficiency Act of 2019" (*McNerney of CA and Kinzinger of IL*), was favorably forwarded to the full Committee, without amendment, by a voice vote.
- (6) H.R. 2044, the "Smart Building Acceleration Act" (Welch of VT and Kinzinger of IL), was favorably forwarded to the full Committee, without amendment, by a voice vote.
- (7) H.R. 359, the "Enhancing Grid Security through Public-Private Partnerships Act" (*McNerney of CA and Latta of OH*), was favorably forwarded to the full Committee, without amendment, by a voice vote.
- (8) H.R. 360, the "Cyber Sense Act of 2019" (*Latta of OH and McNerney of CA*), was favorably forwarded to the full Committee, without amendment, by a voice vote.
- (9) H.R. 362, the "Energy Emergency Leadership Act" (*Rush of IL and Walberg of MI*), was favorably forwarded to the full Committee, without amendment, by a voice vote.
- (10) H.R. 370, the "Pipeline and LNG Facility Cybersecurity Preparedness Act" (*Rush of IL and Loebsack of IA*), was favorably forwarded to the full Committee, without amendment, by a voice vote.

LETTERS

Chairman Frank Pallone, Jr. with Subcommittee Chairs and other House and Senate Leaders

May 1, 2019- Chairman Pallone and Senator Ron Wyden, Ranking Member of the Senate Finance Committee, sent a letter to Seema Verma, Administrator of the Centers for Medicare & Medicaid Services (CMS), expressing their serious concerns regarding ongoing actions taken that weaken important beneficiary protections ensuring access to care. The Committee leaders reference a letter they wrote to HHS about the need for appropriate oversight and enforcement of Medicaid's access standards, as well as CMS guidance and proposed rulemaking on Medicaid managed care that would adversely affect beneficiaries receiving care through managed care.

May 9, 2019- Chairman Pallone and Ranking Member Walden, along with Reps. Mike Doyle and Robert E. Latta, Chairman and Ranking Member of the Subcommittee on Communications and Technology, sent a letter to the Ajit V. Pai, Chairman of the Federal Communications Commission (FCC), regarding the security of 5G infrastructure and technology as part of the newly re-chartered Communications Security, Reliability, and Operability Council (CSRIC), CSRIC VII. In the letter, the Committee leaders expressed their concerns regarding foreign advisories ability to use the equipment, largely built outside the United Sates, for espionage. The letter urges the FCC to use its power granted by Congress to ensure the country's communications networks are being used for the national defense and promotion of safety and property.

May 14, 2019- Chairman Pallone and four other House Committee Chairmen (Rep. Jerrold Nadler, Committee on the Judiciary; Rep. Richard Neal, Committee on Ways and Means; Rep. Elijah E. Cummings, Committee on Oversight and Reform; and Rep. Bobby Scott, Committee on Education and Labor) sent letters to the White House and the Department of Justice asking for documents in response to a request made over a month ago. The documents were in regard to the Administration's decision to reverse its legal position in court and assert that the Affordable Care Act (ACA) in its entirety is unconstitutional.

May 23, 2019- Chairman Pallone and Senator Tom Carper, Ranking Member of the Senate Committee on Environment and Public Works, sent a letter to the Environmental Protection Agency (EPA) requesting information related to the proposed Safe Affordable Fuel-Efficient (SAFE) Vehicles rule. The letter referenced numerous stakeholders, as well as EPA career staffers, who have pointed out the significant legal deficiencies associated with the Administration's proposal. The letter requests answers to four questions regarding the proposal by no later than June 4, 2019.
