Chairman Frank Pallone, Jr., Subcommittee Chairs and other House and Senate Leaders

December 1, 2021 – Chairman Pallone, along with Ranking Member R Cathy McMorris Rodgers, Subcommittee on Oversight and Investigations Chair Diana DeGette and Ranking Member Morgan Griffith wrote to the U.S. Olympic and Paralympic Committee (USOPC) and all National Governing Bodies (NGB) of organized sports to remind them of their obligation to comply with Federal Laws requiring them to report allegations of sexual abuse.

December 2, 2021 – Chairman Pallone, along with Ranking Member Cathy McMorris Rodgers, Subcommittee on Oversight and Investigations Chair, Diana DeGette and Subcommittee Ranking Member Morgan Griffith, Subcommittee on Energy Chairman Bobby Rush and Ranking Member Fred Upton wrote to Honorable Gene L. Dodaro, Comptroller General of the U.S. Government Accountability Office examination of management challenges at Department of Energy (DOE) Office of Environmental Management (EM) that have affected EM’s ability to reduce its environmental liabilities.

December 17, 2021 – Chairman Pallone, along with Ranking Member Cathy McMorris Rodgers, Subcommittee on Communications and Technology Chairman Mike Doyle and Ranking Member Robert E. Latta wrote to Evelyn Remaley, Acting Assistant Secretary of Commerce for Communications and Technology at National Telecommunications and Information Administration (NTIA) regarding FAA and FCC having not agreed to what effect 5G deployments may have in the 3.7 – 3.98 GHz band (C-Band) on aviation navigation tools.
