H.R. 471	Committee on Natural Resources	Fix Our Forests Act
S. 5	Committee on the Judiciary	Laken Riley Act

The Committee granted, by a record vote of 9-3, a rule providing for consideration of H.R. 471, the Fix Our Forests Act, and S. 5, the Laken Riley Act.

The rule provides for consideration of H.R. 471, the Fix Our Forests Act, under a structured rule. The rule waives all points of order against consideration of the bill. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Natural Resources or their respective designees. The rule provides that the bill shall be considered as read. The rule waives all points of order against provisions in the bill. The rule makes in order only those amendments printed in the Rules Committee report. Each amendment may be offered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment, and shall not be subject to a demand for division of the question. All points of order against the amendments printed in the report are waived. The rule provides one motion to recommit.

The rule further provides for consideration of S. 5, the Laken Riley Act, under a closed rule. The rule waives all points of order against consideration of the bill. The rule provides that the bill shall be considered as read. The rule waives all points of order against provisions in the bill. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on the Judiciary or their respective designees. Finally, the rule provides one motion to commit.
