### **COMMITTEE ON ETHICS**

### November 2024

The Committee on Ethics (Committee) continued to fulfill its responsibilities to advise and educate Members and staff on the laws, rules, and standards of conduct. As a general matter, the Committee's activities in receiving and responding to requests for advice from House Members and staff are conducted on a confidential basis. In November, the Committee responded to over 1,000 phone calls and email messages seeking advice, and participated in many informal meetings with Members, House staff, and outside individuals or groups regarding specific ethics matters. The Committee also received 14 requests for formal advisory opinions.

In accordance with the Rules of the House of Representatives for the 118<sup>th</sup> Congress, the Committee continued to review and approve requests to accept privately-sponsored, officially-connected travel. The Committee received and reviewed 34 new travel requests in November 2024 for travel beginning in November or later. Twenty-five employees traveled on a Committee-approved, privately-sponsored, officially-connected trip within the month of November.

The Committee is required under House rules to offer mandatory annual ethics training to each Member, Delegate, Resident Commissioner, officer, and employee of the House. The Committee is working to modernize its guidance in both substance and method of delivery. The Committee continued to provide training in November through live and on-demand offerings. Five individuals attended the live, in-person Ethics training hosted by the Committee on November 7. One individual also attended a specially-scheduled live, in-person training. The Committee also provided live training sessions to 136 Members-Elect and incoming staff at the New Member Orientation Program on November 20.
