COMMITTEE ON ETHICS

June 2012

The Committee continued to fulfill its responsibilities to advise and educate Members and staff on the laws, rules, and standards of conduct. (An enumeration of those laws and rules is found in H. Rep. 111-707, *Summary of Activities, One Hundred Eleventh Congress, A Report of the Committee on Standards of Official Conduct*, 111th Cong., 2d Sess. (Jan. 3, 2011).) As a general matter, the Committee's activities in receiving and responding to requests for advice from House Members and staff are conducted on a confidential basis. The Committee received 33 requests for advisory opinions in June of 2012. Advisory materials the Committee has publicly released are available on the Committee's Web site, at <http://ethics.house.gov/>.

In accordance with the Rules of the House of Representatives of the 112th Congress, the Committee continued to review and approve requests to accept privately-sponsored, officially-connected travel. The Committee received 60 such requests in June of 2012.

In addition, the Committee is required under the House rules to offer annual ethics training to each Member, Delegate, Resident Commissioner, officer and employee of the House. Such training is mandatory for all House officers and employees, and new officers or employees must receive training not later than 60 days after beginning service to the House. The Committee continued to provide such training in June of 2012. The Committee provided live training sessions attended by 406 individuals in June of 2012. The Committee also continued to provide training online, through a number of training videos. Additional information about the calendar of upcoming in-person training sessions and online training opportunities is available on the Committee's Web site, at <http://ethics.house.gov/>.

The Committee released three general advisories in June of 2012. The Committee, with the concurrence of the Chairman and Ranking Member, issued a pink sheet titled *Gift Rules Applicable to National Political Conventions*, on June 1, 2012. The Committee, with the concurrence of the Chairman and Ranking Member, issued a pink sheet titled *Periodic Reporting of Personal Financial Transactions Pursuant to the STOCK Act*, on June 7, 2012. The Committee, with the concurrence of the Chairman and Ranking Member, issued a memorandum titled *Ethics Training Sessions Regarding Periodic Transaction Reports under the STOCK Act*, on June 7, 2012.

Acting Chairman Bob Goodlatte and Acting Ranking Member John Yarmuth, regarding the Matter of Representative Waters, issued a public statement on June 6, 2012, that the Committee unanimously found that no due process rights of Representative Waters have been violated by the Committee in the previous or current Congress. The Committee also released its letter to Representative Waters. On June 8, 2012, the Committee issued a public statement that all 10 Members of the Committee in the matter of Representative Waters sent a response to a

letter received on June 7, 2012 from colleagues. The Committee also released its response letter to colleagues. The notices, releases and public statements are available on the Committee's Web site, at <http://ethics.house.gov/>.


