Chairman Frank Pallone, Jr., Subcommittee Chairs and other House and Senate Leaders

May 11, 2021 – Chairman Pallone, along with Subcommittee on Health Chairwoman Anna G. Eshoo and Subcommittee on Oversight and Investigations Chair Diana DeGette wrote to the Honorable Xavier Becerra, Secretary of the Department of Health and Human Services (HHS), urging him to reverse the Trump Administration’s policy which removed the Food and Drug Administration (FDA) premarket review requirements for COVID-19 laboratory developed tests.

May 19, 2021 – Chairman Pallone and Representative Barbara Lee wrote to the Honorable Xavier Becerra, Secretary of HHS, regarding provisions included in American Rescue Plan (ARP) Act of 2021 to make sure resources are made available to communities that are hardest hit by the impact of COVID-19 pandemic.

May 20, 2021 – Chairman Pallone, along with Ranking Member Cathy McMorris Rodgers, Subcommittee on Oversight and Investigations Chair Diana DeGette and Ranking Member Morgan Griffith, and Subcommittee on Environment and Climate Change Chairman Paul Tonko and Ranking Member David McKinley wrote to Katherine Lemos, CEO of the Chemical Safety and Hazard Investigations Board (CSB) demanding information regarding ongoing management, resources and personnel challenges it continues to face.

May 26, 2021 – Chairman Pallone and Senator Patty Murray, Chair of the Senate Committee on Health, Education, Labor and Pensions, wrote to the general public announcing plans to develop legislation to establish a public option for health coverage to lower health care costs. The Chairs issued a Request for Information (RFI) to request the public’s input as they begin to draft legislation for the public option.

May 27, 2021 – Chairman Pallone, along with Subcommittee on Health Chairwoman Anna G. Eshoo, Subcommittee on Oversight and Investigations Chair Diana DeGette, Subcommittee on Communications and Technology Chairman Mike Doyle, and Subcommittee on Consumer Protection and Commerce Chair Jan Schakowsky wrote to Mark Zuckerberg, Chairman and CEO of Facebook; Jack Dorsey, CEO of Twitter; and Sundar Pichai, CEO of Google demanding answers as part of their investigation into the technology companies continued mishandling of COVID-19 disinformation.
