June 2020

**I. Full Committee Progress**

June 10th, the full committee met to receive testimony on the Department of Defense COVID-19 response to defense industrial base challenges.

**II. Subcommittee Progress**

Tactical Air and Land Forces Subcommittee

June 23<sup>rd</sup>, the subcommittee met to markup H.R. 6395, the National Defense Authorization Act for Fiscal Year 2021 to authorize appropriations for aircraft, rotorcraft, ground equipment, ammunition, reconnaissance and surveillance platforms, and for other purposes.

Readiness Subcommittee

June 23<sup>rd</sup>, the subcommittee met to mark up H.R. 6395, to authorize appropriations for fiscal year 2021 for military activities of the Department of Defense, to allocate funding for military construction, operations and maintenance, training, logistics, and for other purposes.

Intelligence and Emerging Threats and Capabilities Subcommittee

June 22<sup>nd</sup>, the subcommittee met to markup H.R. 6395, the National Defense Authorization Act for Fiscal Year 2021, to authorize appropriations for national and military intelligence programs, special operations forces and sensitive military activities, cyber operations and cybersecurity, countering weapons of mass destruction, and science and technology programs, and for other purposes .

Military Personnel Subcommittee

June 16<sup>th</sup>, the subcommittee met to receive testimony on racial disparity in the military justice system.

June 23<sup>rd</sup>, the subcommittee met to mark up H.R. 6395, to authorize appropriations for fiscal year 2021 for military activities of the Department of Defense and for military construction, to prescribe military personnel strengths for such fiscal year, and for other purposes.

Strategic Forces Subcommittee

June 22<sup>nd</sup>, the subcommittee met to mark up H.R. 6395, to authorize appropriations for fiscal year 2021 for nuclear weapons activities of the Department of Defense and Department of Energy and for national security space programs, for missile defense and missile defeat programs, and for other purposes.

Seapower and Projection Forces Subcommittee

June 23<sup>rd</sup>, the subcommittee met to markup H.R. 6395, to authorize appropriations for fiscal year 2021 for military activities of the Department of Defense, to authorize acquisition programs related to shipbuilding and conversion, and for other purposes.
