SUMMARY ONE	On August 7, 2026, Representative Nancy Mace published the following statement through her verified "RepNancyMace" social-media accounts: "Every single Muslim holding public office in America is a trojan horse, and a threat to both national security and our republic. We refuse to be silent." This was not criticism of a particular policy, organization, action or security concern. It accused every Muslim American holding public office of secret disloyalty and dangerousness solely because of religion.

	The House Communications Standards Manual provides that official communications may not be used to disparage Members or other individuals, including through personal attacks or attacks upon character, and prohibits speculation regarding an individual's motivation or intent. It further provides that official social-media content must comply with applicable House rules. Representative Mace's communication directly attacks the character and loyalty of identifiable Muslim public officials and imputes a secret hostile motive to them without identifying evidence or individual conduct. I request that the Commission determine whether official House communications resources were used and take appropriate corrective or disciplinary action.

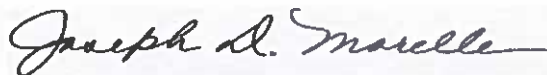
Additionally, given this communication was posted on social media with no direct cost to the taxpayer; reimbursement to the U.S. Treasury is not applicable.
