Dear Representative Steil:

Thank you for your correspondence regarding the alarming events in Connecticut surrounding the recent mayoral primary in Bridgeport. A new Democrat primary election has been ordered due to this ballot box tampering and has been scheduled for Jan. 23, 2024.

As way of background, this is not the first time that Bridgeport has made headlines for alleged ballot fraud¹. In 2019, questions about the use of absentee ballots in Bridgeport arose and the State Election Enforcement Commission referred three people, including two city employees, for criminal charges.

And sadly, this is not limited to Bridgeport. In Stamford, a Democrat was convicted of forging signatures on multiple absentee ballot applications². He was sentenced to probation but is appealing his conviction. These incidents, as well as others across the country, bring the security of absentee ballot boxes and other aspects of our elections into question. The integrity of the electoral process demands that it be free of tampering so that voters have faith in the system; incidents like these only add to the suspicions of corruption.

As Ranking Members of the Government Administration and Elections Committee, we have continually voiced grave concerns about the potential for fraud in our elections, engaging in lengthy debates and offering countless amendments. Despite offering commonsense solutions and legislation to improve the security of the process, such as requiring an ID to cast a ballot, verifying signatures on ballots, or placing the ballot drop boxes in a place where they can be continually monitored, the Democrat majority in the House and Senate have failed to act.

The integrity of our elections is of paramount importance to the Republican members of the GAE Committee. Senate and House Republicans have also worked tirelessly to implement protections that would maintain the integrity of our voting system.

Because Democrats hold majorities in both chambers, they control the agenda and our many bill proposals regarding election integrity provisions are never brought up. Our alternative is to use the amendment process.

Here are just some of the recent attempts we've made from recent sessions. Each and every one was voted down by Democrats on party lines:

- 2022: LCO 3592 on H.B. 5262 Rolls back COVID-19 rules on voting by AB
- 2021: LCO 8915 on H.B. 6205 No mailing unsolicited AB Applications by SOTS
- 2021: LCO 8934 on H.B. 6205 Rolls back COVID-19 rules on voting by AB

We wish we could be optimistic that our colleagues across the aisle will now join us in our pursuit to secure Connecticut's elections as the issue has reached critical mass, but history suggests otherwise.
