

Due to a payroll processing error, she did not receive the stated increase. On 12/1, she received

the difference of what was owed from her previous salary of \$95,000/yr, \$7,916.67/mo and the

difference owed to her in the amount of \$2,750 in a separate check. In December, her salary will

reflect her new monthly salary of \$10,666.68 and payment owed of \$2,750 for a total of \$13,416.67
