Dear Mrs. Farah Griffin,

I write to you in my capacity as Chairman of the Committee on House Administration Subcommittee on Oversight (“Subcommittee”), which has jurisdiction over the safety and security of the United States Capitol.<sup>1</sup> My Subcommittee is also the custodian of all records archived by the Select Committee to Investigate the January 6th Attack on the United States Capitol (“Select Committee”).<sup>2</sup> It is imperative the Subcommittee review any and all materials pertaining to January 6, 2021, to fulfill its oversight responsibilities and ensure the safety and security of the United States Capitol.<sup>3</sup> It is also essential that this Subcommittee fully investigate claims made by Ms. Hutchinson which directly implicates security concerns for the United States Capitol.

According to public reports, numerous sit-down interviews, and Cassidy Hutchinson’s memoir *Enough*, you spoke to Ms. Hutchinson about her testimony to the Select Committee during the summer of 2021.<sup>4</sup> A review of the documents provided by the Select Committee resulted in questions about the veracity of Ms. Hutchinson’s public and private testimony to the Select Committee. Ms. Hutchinson specifically cites her conversation with you as one reason her testimony changed so dramatically.

For example, in *Enough*, Ms. Hutchinson claims that you and her “talked over [her] options, and [you] agreed to contact Liz Cheney on [her] behalf about scheduling another interview [with the Select Committee].”<sup>5</sup> She then recounts that during this conversation, she shared that the Select Committee “never asked if [she] went to the Oval [Office] dining room on January 6, or whether [she] heard about Trump’s reaction to the rioters chanting ‘Hang Mike Pence.’ According to Mark [Meadows], Trump said, ‘He deserves it.’”<sup>6</sup> These stories Cassidy has later claimed to have been privy to were never discussed prior to this meeting at your Georgetown row house. There are no texts, emails, or verbal exchanges that have been verified where Ms. Hutchinson discussed these explosive claims, apart from your conversation, before testifying to the Select Committee.

Therefore, due to your proximity to and influence on Ms. Hutchinson around the time her testimony changed so drastically, I believe you may have important information related to the Subcommittee's investigation. To aid in the Subcommittee's investigation into the security and intelligence failures on January 6, 2021, I request that you produce the following:

- All communications with former Vice Chair of the Select Committee Liz Cheney from June 30, 2021, until today, June 4, 2024;
- All communications with former Special Assistant to the President and Coordinator for Legislative Affairs Cassidy Hutchinson from July 1, 2020, until today, June 4, 2024;
- All communications with former White House Chief of Staff Mark Meadows from October 1, 2020, until January 3, 2023;
- All communications with former White House Deputy Chief of Staff Anthony (Tony) Ornato from October 1, 2020, until January 3, 2023;
- All communications with former White House Senior Advisor to the President Eric Herschmann, former White House Counsel Pat Cipollone, and former Deputy Counsel to the President Patrick Philbin from October 1, 2020, until January 3, 2023;
- All communications with former United States Secret Service agent Robert (Bobby) Engel from October 1, 2020, until January 3, 2023;
- All communications with any Secret Service agent assigned to Chief of Staff Meadows or President Trump at any point from November 3, 2020, until February 1, 2021;
- Copies of phone logs for all devices, personal or official, from October 1, 2020, until January 3, 2023;
- Any calendar, personal or official, maintained from November 3, 2020, until January 3, 2023;
- All communications referencing or referring to Cassidy Hutchinson's employment after White House service from November 1, 2020, until January 3, 2023;
- All communications referencing or referring to Cassidy Hutchinson's employment after White House service from November 1, 2020, until January 3, 2023;
- All communications referencing or referring to Cassidy Hutchinson's public and private testimony to the Select Committee from June 30, 2021, until January 3, 2023;
- All communications referencing or referring to January 6 or the events of January 6 from November 3, 2020, until January 3, 2023;
- All communications referencing or referring to the 25th Amendment from October 1, 2020, until January 3, 2023;

- All communications referencing or referring to Cassidy Hutchinson's potential publishing or book deals or related compensation from June 30, 2021, until September 26, 2023;
- All communications referencing or referring to the Fulton County District Attorney's Office in Georgia from January 1, 2021, until August 14, 2023;
- Any communications with any representative of the Fulton County District Attorney's Office in Georgia from January 1, 2021, until August 14, 2023;
- All documents or notes prepared by you for interviews with the Select Committee, the Department of Justice, or for any other Congressional or law enforcement interview.

Additionally, the Subcommittee requests that you make yourself available for a transcribed interview at our offices in Washington, DC. I ask that you contact my office to arrange for a mutually agreeable date and time for this interview by June 18, 2024.

Please provide all responsive materials no later than June 18, 2024. Thank you for your cooperation in this important oversight matter to ensure the security of the U.S. Capitol Building, Members, staff, and visitors.
