June 18, 2020 – Members of the Committee on Energy and Commerce, Subcommittee on Communications and Technology held a bipartisan teleconference forum with Charles Mathias, Associate Bureau Chief of the Wireless Telecommunications Bureau at the Federal Communications Commission (FCC), Ron Repasi, Acting Chief of the Office of Engineering at Technology at the FCC, Fred Moorefield, Deputy Chief Information Officer for Command, Control, and Communications at the Department of Defense, and Charles Cooper, Associate Administrator, Office of Spectrum Management at the National Telecommunications and Information Administration. The forum’s focus was FCC’s approval of Ligado’s request for a license modification in the L-band.

During the month of June, the Committee on Energy and Commerce staff, at the director of the Chairman and its members, worked on developing and providing the best tools to enable its members to safely convene and work together on the important issues under the Committee’s jurisdiction.
