SUBJECT: **Access to the House Office Buildings Saturday, August 22, 2020**

When the House returns in regular session on **Saturday, August 22, 2020**, the following vehicle barricades, garages and pedestrian entrances will be open for access. When the House is in a District Work Period and/or is in a Committee Work Day posture, vehicle barricades, garages and pedestrian entrances will return to current access levels until further notice.

### **Vehicular Barricades**

- **New Jersey Avenue & Independence Avenue, SE** 24 hours
- **First Street & C Street, SE (C Street)** 5:00 AM – 3:00 PM (or 30 minutes after adjournment)
- **Washington Avenue & C Street, SW (C Street)** 5:00 AM – 9:00 PM
- **First Street, SW & Washington Avenue (First Street)** 7:30 AM – 3:00 PM (or 30 minutes after adjournment)
- **First Street & Independence Avenue, SW (*Outbound Only*)** 7:30 AM – 3:00 PM (or 30 minutes after adjournment)

### **Garages**

Offices who are expecting official business visitors are required to greet guests outside an entrance and be prepared to escort them to and from any meeting. In addition, the Capitol remains open only to Members, staff and official business visitors. Offices who are expecting official business visitors to the Capitol are required to greet guests outside the South Door of the Capitol and to escort them to and from each meeting. The Capitol and CVC remain closed to all tours, including Member, staff-led and public tours.

Once again, when the House is in a Committee Work Day posture and/or is in a District Work Period, vehicle barricades, garages and pedestrian entrances return to current access levels.
