FOR THE MONTH OF NOVEMBER 2019**

The Full Committee conducted the following hearings and/or meetings during the month of November 2019:

Wednesday, November 20, 2019--- The Full Committee sought and obtained unanimous to place on the agenda and Markup H.R. 307, To provide for partnerships among State and local governments, regional entities, and the private sector to preserve, conserve, and enhance the visitor experience at nationally significant battlefields of the American Revolution, War of 1812, and Civil War, and for other purposes. "*Preserving America's Battlefields Act.*"

Wednesday, November 20, 2019--- The Full Committee held a Markup on H.R. 1708, To adjust the boundary of the Santa Monica Mountains National Recreation Area to include the Rim of the Valley Corridor, and for other purposes. "*Rim of the Valley Corridor Preservation Act.*"

Wednesday, November 20, 2019--- The Full Committee held a Markup on H.R. 2199, To designate certain Federal land in the State of California as wilderness, and for other purposes. "*Central Coast Heritage Protection Act.*"

Wednesday, November 20, 2019--- The Full Committee held a Markup on H.R. 2215, To establish as a unit of the National Park System the San Gabriel National Recreation Area in the State of California, and for other purposes. "*San Gabriel Mountains Foothills and Rivers Protection Act.*"

Wednesday, November 20, 2019--- The Full Committee held a Markup on H.R. 2250, To provide for restoration, economic development, recreation, and conservation on Federal lands in Northern California, and for other purposes. "*Northwest California Wilderness, Recreation, and Working Forests Act.*"

Wednesday, November 20, 2019--- The Full Committee held a Markup on H.R. 2546, To designate certain lands in the State of Colorado as components of the National Wilderness Preservation System, and for other purposes. "*Colorado Wilderness Act of 2019.*"

Wednesday, November 20, 2019--- The Full Committee noticed and did not consider H.R. 2642, To designate and expand wilderness areas in Olympic National Forest in the State of Washington, and to designate certain rivers in Olympic National Forest and Olympic National Park as wild and scenic rivers, and for other purposes. "*Wild Olympics Wilderness and Wild and Scenic Rivers Act.*"

Wednesday, November 20, 2019---The Full Committee held a Markup on H.R. 2854, To amend the National Wildlife Refuge System Administration Act of 1966 to prohibit the use of neonicotinoids in a National Wildlife Refuge, and for other purposes. *"Protect Our Refuges Act of 2019."*

Wednesday, November 20, 2019---The Full Committee held a Markup on H.R. 3794, To promote the development of renewable energy on public lands, and for other purposes. *"Public Land Renewable Energy Development Act of 2019."*

Wednesday, November 20, 2019--- The Full Committee sought and obtained unanimous consent to place on the agenda and Markup S. 216, To provide for equitable compensation to the Spokane Tribe of Indians of the Spokane Reservation for the use of tribal land for the production of hydropower by the Grand Coulee Dam, and for other purposes. *"Spokane Tribe of Indians of the Spokane Reservation Equitable Compensation Act."*
