Tuesday, June 2, 2020—The Subcommittee on National Parks, Forests, and Public Lands held a Digital Forum on “Not So Grand Opening: Examining local perspectives on Department of the Interior’s plan to reopen National Parks during the COVID19 Pandemic.”

Wednesday, June 10, 2020--The Subcommittee on National Parks, Forests, and Public Lands held a Digital Forum on “Examining Coronavirus Impacts on Wildland Fire Operations and Vulnerable Communities.”

Thursday, June 18, 2020— The Subcommittee on National Parks, Forests, and Public Lands held a Remote Legislative Hearing on H.R. 244, To maximize land management efficiencies, promote land conservation, generate education funding, and for other purposes. “*Advancing Conservation and Education Act*”

Thursday, June 18, 2020— The Subcommittee on National Parks, Forests, and Public Lands held a Remote Legislative Hearing on H.R. 1267, To designate a mountain ridge in the State of Montana as “B-47 Ridge”. “*B-47 Ridge Designation Act*”

Thursday, June 25, 2020—The Subcommittee on Water, Oceans, and Wildlife held a Hybrid Legislative hearing on H.R. 1776, To amend the Lacey Act Amendments of 1981 to prohibit importation, exportation, transportation, sale, receipt, acquisition, and purchase in interstate or foreign commerce, or in a manner substantially affecting interstate or foreign commerce, of any live animal of any prohibited wildlife species. "*Captive Primate Safety Act*"

Thursday, June 25, 2020—The Subcommittee on Water, Oceans, and Wildlife held a Hybrid Legislative hearing on H.R. 2264, To conserve global bear populations by prohibiting the importation, exportation, and interstate trade of bear viscera and items, products, or substances containing, or labeled or advertised as containing, bear viscera, and for other purposes. "*Bear Protection Act of 2019*"
